### **Sustainable Tourism-From Theory to Practice**

On 9 September the TRC organised another exciting event attended by about 30 staff and students, an afternoon dedicated to the discussion on the implementation of sustainable tourism. The seminar included a presentation by Professor Werner Gronau from the University of Stralsund in Germany, who introduced a conceptual model for the utilisation of cultural heritage to promote sustainability in the context of niche tourism by using a case example from Cyprus.

This was followed by a presentation *via* a Skype® videolink by Emeritus Prof Richard Butler from the University of Strathclyde, Scotland who is widely regarded as an international authority on sustainable tourism. Prof Butler highlighted the still existing difficulties in the implementation of sustainable tourism and stressed the importance of the local level for it to be more successful in practice.

# Associate Professor Christof Pforr speaks at International Tourism Conferences in Rhodes, Singapore and in Mauritius

Associate Professor Christof Pforr presented two papers at an international tourism conference (Tourism in the Era of Uncertainty) on the Greek Island Rhodes (27-30 April 2011). One paper explored the potential of health regions as tourism destinations and the second paper examined the tourism strategic planning process in the Northern Territory of Australia. A/Prof Pforr was also member of the conference's scientific committee and chaired a session on 'Perspectives of Tourism Sustainability'.

In July, A/Prof Pforr participated in the 12<sup>th</sup> International Conference of the Society for Global Business & Economic Development in Singapore. 'From patient to guest: Current trends in the German health care industry and their impacts on the tourism sector' was the title of his presentation on a joint research project with A/Prof Connie Locher from the University of Western Australia.

From 21-24 September, A/Prof Pforr participated in the very interesting International Tourism Sustainability Conference 2011 'Embracing Social and Environmental Change, The Influence and Role of Tourism'. He presented a joint paper with Prof Reiser from Cologne Business School (Germany) on the South Pacific Island of Niue, titled 'Small is Beautiful and Sustainable? Tourism on Niue, the Rock of the Pacific'.

# Professor Jack Carlsen presents at the University of South Pacific Island Tourism conference, Fiji

Professor Jack Carlsen recently presented at the Islands and Small States Tourism Conference hosted by the University of South Pacific, Suva, Fiji. Around 65 delegates from university and the public and private sector discussed the broad range of issues and opportunities confronting island tourism destinations around the world, with a special focus on Pacific Island States. As part of his keynote address, Professor John Tribe introduced the new publication *Island Tourism: Sustainable Perspectives* (edited by Prof Carlsen and Prof Butler) which was received favorably by the conference delegates. Case studies, including the Maldives, presented by Prof. Carlsen, provided further lessons for delegates to apply upon their return to their respective organisations and destinations.

# Work life balance in the hospitality industry and the relationship to substance abuse

On 11 August, as part of the School of Management's Research Seminar Series, Adjunct Professor Margaret Deery gave an interesting and well received presentation on 'Work-life Balance in the Hospitality Industry and the Relationship to Substance Abuse'. In the context of previous studies in Australia that suggested employees in the hospitality industry to have a higher rate of substance abuse than employees in other industries, Prof Deery presented comparative data from the UK, Australia and New Zealand to discuss the relationship between substance abuse and work-life balance. With the findings of their study Prof Deery and her team hope to assist both employees and managers in better dealing with work-life issues to enable higher work life balance satisfaction.

## Dr Cornelia Voigt appointed as Adjunct Research Fellow



The Tourism Research Cluster is very pleased to be able to welcome Dr Cornelia Voigt to the network as an Adjunct Research Fellow. Cornelia has worked as a researcher and lecturer at different universities. She holds a Bachelor of Information Management from the Hochschule der Medien in Stuttgart, Germany and a Master of Strategic Marketing from the University of Wollongong in Australia. In May 2010 she was awarded with a PhD from the School of Management, University of South Australia. In her teaching activities Dr Voigt has focused on tourism and hospitality marketing, impacts of tourism

and event management. Dr Voigt's thesis, titled "Understanding Wellness Tourism: An Analysis of Benefits Sought, Health-Promoting Behaviours and Positive Psychological Well-Being" was awarded with the "Sustainable Tourism CRC Sir Frank Moore Award for Excellence in PhD Research", an annual, national award acknowledging the best tourism thesis written in each year. Her research won several additional awards and she has published in leading international tourism journals. Dr Voigt's expertise in wellness tourism has lead to the acquisition of competitive research grants and the invitation as a keynote speaker at international conferences.

# Adjunct Professor Margaret Deery's Visit to the University of Southern Denmark (USD)

Professor Margaret Deery recently spent some time at the University of Southern Denmark (USD) working with Associate Professor Janne Liburd and teaching into the European Masters in Tourism

Management. Over thirty students were selected for the program from 700 applicants from around the world with a third of their course being undertaken in Denmark and the remaining time being spent in Girona and Lubiana. Professor Deery presented a workshop on corporate social responsibility in the private sector. As a member of the Advisory Board for the Tourism Masters at USD she also worked with Dr Liburd on curriculum development for the Masters in International Tourism and Leisure Management at the USD.

# Dr Paull Weber Keynote Speaker at ACCC Small Business Scams Forum

Dr Paull Weber was the invited keynote speaker at the ACCC Small Business Scams forum in Canberra on 13 September 2011. The preliminary research data presented was extracted from the 2011 iteration of WA Small Business Benchmarks and included cases from tourism and hospitality businesses as well as many other industries. The data highlights a worryingly high level of loss in terms of both time and money by Australian small firms and is a call to action for more research in this area. As a consequence, Dr Weber has been awarded a CBS Linkage With Business Grant of \$16,000 to develop this line of research in partnership with the ACCC. ## Postgraduate student wins specialised grants

Lesley Crowe-Delaney won two specialised grants this year, the Japan Study Grant at the National Library of Australia, Canberra and Japan Foundation Classical Japanese Workshop, Sydney, both of which were taken up this year. She presented a paper at the Institute of Australian Geographers, Wollongong on Coastal Development and the recent Tsunami in Japan and also conducted a session on rural coastal development in advanced economies. She is finalising her PhD for 2011 submission. She is listed on the www.seafood.net.au/ directory and has been offered projects through the Fisheries Research and Development Corporation's web project, 'Empowering Industries'.

## **Professor Ross Taplins recent research publications**

Ross Taplin has had two methodological papers appear recently in Tourism Management:

'Competitive Importance-Performance Analysis of an Australian Wildlife Park' (vol 33: p. 29-37) and 'The value of self-stated attribute importance to overall satisfaction' (doi:10.1016/j.tourman.2011.03.008). The first shows how results from IPA can differ when the impact of venues competing for tourist visitation are taken into account and the second demonstrates how visitor self-stated importance of venue attributes are predictive of overall satisfaction if relative importance rather than absolute importance is used.

# A/Professor Pforr appointed to Editorial Board and Conference Scientific Committee

A/Prof Christof Pforr was recently appointed to the Editorial Board of the International Journal of Safety and Security in Tourism / Hospitality. He is also a Scientific Committee member of the upcoming International Conference on Tourism 2012 'Setting the Agenda for Special Interest Tourism; Past, Present and Future', which will be held on Crete, Greece 23-26 May 2012.

## **PROJECTS**

#### **Beach and Surf Tourism**

Prof. Jack Carlsen has joined a research team based at Bond University, Gold Coast looking into Beach and Surf Tourism: Vulnerability and Adaptation. The project will include case studies of four surfing regions of Australia in Queensland, NSW, Victoria and Western Australia and is funded by the Department of Climate Change and Energy Efficiency and the Fisheries Research and Development Corporation.

# Community and Socio-economic impacts of World Heritage on Shark Bay and the Ningaloo Coast, WA

Dr Michael Hughes is working with Prof. Roy Jones, Dr Tod Jones (Curtin University, Humanities) and Dr Joseph Christensen (Murdoch University) on a research project to understand the social and economic impacts of World Heritage listings on local communities. Funded by the WA Department of Environment and Conservation and Tourism WA with \$15,000, the project will gather documented and anecdotal evidence from each region. Comparative analysis will provide insights into how Shark Bay has changed over time, and how this compares to local community views on

recent World Heritage listing in the Ningaloo Coast region. This will provide insight into the impacts of World Heritage listing on remote tourism destinations and communities.

#### **Munda Biddi Trail User Survey**

Dr Michael Hughes, in collaboration with the WA Department of Environment and Conservation (DEC) has recently completed a survey analysis of Munda Biddi Cycle Trail users. The trail currently extends 491km south from the Town of Mundaring along the Darling Range to the town of Nannup. Once fully completed, the trail will extend 1000 km through the south-west of WA to the City of Albany on the southern coast. The main objective of the user survey was to obtain an indication of levels of trail use, market segments, frequency and patterns of use, satisfaction levels and expenditure. This will inform future planning, management, maintenance, sponsorship and marketing of the trail for tourism and recreation.

#### **ERA: The Curtin University Academic Researcher Experience**

Dr Michael Hughes in collaboration with A/Prof Dawn Bennett (Curtin University, Humanities) recently completed a study focused on the experiences of research-intensive academics in relation to the Excellence in Research for Australia Framework. The project included a written questionnaire and in-depth interviews into how changes in the system of University research performance assessment impact on research and publication patterns. Documenting the experience of researchers up to and including the decision to abandon journal ranking provided valuable insights into the precarious and reactionary nature of academic research careers, and the capacity of both individuals and institutions to negotiate the rapid rate of change. The research has been submitted to the *Higher Education Research and Development Journal* and is currently under review.

#### **Annual Bill Faulkner PhD and ECR Workshop**

Dr Michael Hughes is once again developing, coordinating and delivering the annual Bill Faulkner Workshop for PhD and Early Career tourism and hospitality scholars, to be held in Melbourne on Feb. 6, 2012. The workshop runs in conjunction with the annual CAUTHE conference and attracts national and international participants. Michael is collaborating with the CAUTHE conference organizers at Latrobe University as well as colleagues at Monash University and the University of South Australia. The one day workshop includes an engaging program with opportunities to network with fellow scholars and internationally renowned tourism and hospitality professors.
